Westoba Announces Director Election Results, AGM and Releases 2018 Annual Report

BRANDON, MB – George Henderson of La Riviere was successful in being re-elected to the Board of Directors by the members of Westoba Credit Union (WCU) in District 3 (Killarney/Ninette/Cartwright/Swan Lake/Pilot Mount/La Riviere/Winnipeg).

“We sincerely thank everyone who participated in the election process from the candidates to our many voters,” says WCU Board Director and Governance Committee Chair Elizabeth (Liz) Roberts. “As a cooperative, it is important our members are actively involved in helping set the direction of our credit union.”

Also, in District 3, the Board appointed **Douglas Wanyoike** to complete the last of the two years remaining in Annette Horst’s three-year term. Ms. Horst resigned from her position last fall for professional reasons. The Westoba members will be asked to ratify this appointment at the Annual General Meeting (AGM) on April 24th.

In District 2 (Carberry/Glenboro/Souris/Rivers/The Pas), no election was held. One member, Henry Maryniuk, let his name stand for election. **Henry Maryniuk** has been acclaimed and will serve a three-year term on the Board.

In District 1 (Brandon/MAXA) no candidate nominations were received. As a result, the Board has appointed **Garnet McBurney** to serve a three-year term. Westoba members will be asked to ratify this appointment at the AGM on April 24th.

Westoba members can meet new and returning Board Directors at Westoba’s **Annual General Meeting (AGM) on Wednesday, April 24th at the MNP Hall, Keystone Centre in Brandon MB**. Chair Board, Jim Abernethy and Chief Executive Officer, Jim Rediger will speak to the 2018 Annual Report, and applicant winners of the 2018 Inspire giving program will be guest speakers for the evening. Doors open at 6:15 and the meeting will start at 7:00pm.
